## 2-8-2025 Dream Car Raffle

### Official Raffle Rules to Win ARC's Dream Car Raffle

**Grand Prize: 2004 Thunderbird or \$10,000 Cash**

**2nd Prize \$500 Cash • 3rd Prize \$200 Cash**

- 1.Void where prohibited by law.
- 2.Eligibility: Anyone 18 or older may enter (ID will be required to verify age). Board members, Directors and Officers of the Rec. Centers of Sun City, Inc., and the Automotive/Restoration Club (ARC) of Sun City West may participate in the raffle, but may not receive any direct or indirect pecuniary benefit from the Dream Car Raffle.
- 3.Raffle will end on February 8, 2025.
- 4.Tickets: 6,000 two-part, sequentially numbered raffle tickets will be sold at the rate of 1/\$20. or 6/\$100.
- 5.Drawing for a winner will be held on Saturday, February 8, 2025, at 2:00 PM Mountain Standard Time at the R.H. Johnson Rec. Center, 19803 R.H. Johnson Blvd., Sun City West, AZ 85375. There will be no ties.
- 6.The winner will be notified immediately following the drawing using the information provided by the purchaser of the ticket. In addition, the winner's name will be posted on the Internet, at the Rec. Center of Sun City West, Inc., ARC, etc. The winner need not be present to win.
- 7.The winner must claim the vehicle or cash within 10 days of the notification of winning.
- 8.The winner is responsible for making their own arrangements for delivery of the vehicle or cash winnings within 10 days of the drawing as well as paying for the delivery.
- 9.The winner assumes all fees, local, state and federal taxes (including but not limited to income taxes based on the value of the vehicle, DMV tax and fees) which must be paid when the vehicle is transferred to the winner. Winner will be responsible for vehicle insurance (proof of insurance from the winner will be required on the vehicle before the vehicle may be moved). The same is true for cash winnings.
- 10.The vehicle will be transferred to the winner **As Is, Where Is, and with all faults**. ARC and the Rec. Centers of Sun City West, Inc. does not provide any guarantee or warranty, expressed or implied, in connection with the car and accepts no liability or responsibility regarding the condition of the car. ARC and the Rec. Centers of Sun City West, Inc. do not warrant that the car is of merchantable quality or that it can be used for any particular purpose. No express warranties are given and no affirmation of ARC and the Rec. Centers of Sun City West, Inc. by words and/or actions will constitute a warranty.
- 11.If the name of more than one person is submitted with a ticket purchase and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of the prize by a group purchasing a ticket in common shall be to the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner.
- 12.If a winner does not claim their prize within 10 days of notice using the information provided on the ticket, such winner will be deemed to have forfeited their opportunity and a second raffle ticket will be drawn for the prize.
- 13.ARC will file all paperwork with all involved governmental agencies regarding reporting the winner of the Dream Car Raffle.
- 14.Winner agrees to complete all appropriate and applicable forms requested as well as pay 24% federal income tax withholding to ARC prior to release of the vehicle. ARC will submit the taxes collected to the IRS and will file all forms necessary with the IRS to report the value of the prize won and the taxes paid in by the winner. The winner will also receive a copy of a W-2G.
- 15.The odds of winning the vehicle or cash will depend on the number of tickets sold.
- 16.Note: The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions.
- 17.By entering this raffle, entrants accept and agree:
  - a.To be bound by all the rules, limitations and restrictions set forth here and
  - b.That their names and/or likenesses may be disclosed to and used by the news media and may otherwise be used by the Rec. Centers of Sun City West, Inc. and ARC for publicity purposes and in a listing of the prize winner to be published in area newspapers, announced on the Internet and in the news media.
